Policy Advisory Committee Guiding Principles

- Policies and programs that are trauma-informed, evidence-supported, family-focused, culturally-responsive and community-based.
- Policies and programs that support families, empower communities and prevent involvement in the formal juvenile justice and child welfare systems.
- Policies and programs that ensure out-of-home placement in juvenile detention or foster care is used only when necessitated by safety concerns that cannot otherwise be mitigated, and occurs in the least restrictive setting, for the least time possible, and close to the child's family and community.
- Policies and programs that advance racial equity and reduce the entrenched patterns of disproportionate representation and disparate outcomes for minority children, youth and families involved in the juvenile justice and child welfare systems.
- Policies and administrative practices that provide full funding for community services to enhance the well-being of children, youth and families.
- Policies and administrative practices that support a well-qualified, trained and stable workforce serving children, youth and families.
- Policies and administrative practices that safeguard the interests of marginalized children, youth and families throughout the State's design, implementation and administration of Medicaid and managed care arrangements for community social services.
- Policies and administrative practices among community youth service, juvenile justice and child welfare providers to measure their performance, evaluate outcomes and apply sound continuous quality improvement practices.
- Policies, legislation and programs that fulfill ICOY's strategic imperative to take a strong stance on social justice issues that impact Illinois' children, youth and families.
